

Medical Requirements for Humanitarian Parole under Uniting for Ukraine



Polio

Get your child vaccinated for polio within 14 days of U.S. arrival or when they reach vaccine approval age (2 months and older).

WHO DO THESE REQUIREMENTS APPLY TO?

- + Children over 2 months old
- + Adults

MUST BE COMPLETED

WITHIN 14 DAYS OF U.S. ARRIVAL

COVID-19

Complete a full COVID-19 vaccine series within 90 days of U.S. arrival or when your child reaches the eligible age (6 months and older), whichever is later.

WHO DO THESE REQUIREMENTS APPLY TO?

- + Children over 6 months old
- + Adults

MUST BE COMPLETED

WITHIN 90 DAYS OF U.S. ARRIVAL

Tuberculosis

Complete Tuberculosis Screening and the required attestation on your USCIS online profile within 90 days of U.S. arrival.

WHO DO THESE REQUIREMENTS APPLY TO?

- + Children over 2 years old
- + Adults

MUST BE COMPLETED

WITHIN 90 DAYS OF U.S. ARRIVAL



Make sure to complete an IGRA blood test rather than a skin test.



NOT FOLLOWING THE MEDICAL/VACCINE/TESTING REQUIREMENTS OF PAROLE COULD PUT YOUR PAROLE AT RISK, INCLUDING POSSIBLE TERMINATION OF PAROLE.

IT IS IMPORTANT TO ASK YOUR DOCTOR FOR A COPY OF YOUR HEALTH RECORD AND TO KEEP YOUR RECORD IN A SAFE PLACE.

Polio Vaccine

Approved for ages two months and older

If you attested that your child was not vaccinated against polio because the vaccine is not approved or licensed for use in their age group, you will need to:

- ✓ Get your child vaccinated for polio within 14 days of arrival in the U.S. or when they reach vaccine approval age (two months and older).

COVID-19 Vaccine

Approved for ages six months and older

If you attested that you or your child received at least one dose of an approved COVID-19 vaccine, but were not fully vaccinated, you will need to:

- ✓ Complete a recommended COVID-19 vaccine series within 90 days after arrival. For humanitarian parole under U4U, “fully vaccinated” for COVID-19 means that you have completed your primary vaccine series.

If you attested that your child had not received at least one dose of an approved COVID-19 vaccine but qualified for an exception to this requirement because they are too young, you will need to:

- ✓ Start a COVID-19 vaccine series within 90 days of arrival to the United States or when your child reaches the eligible age (six months and older), whichever is later. You will also need to complete the recommended primary vaccine series so your child is considered fully vaccinated.

If you attested that you or your child is not vaccinated against COVID-19 because the vaccine is not approved or licensed for use in you or your child’s age group in the place you were residing before coming to the U.S., you will need to:

- ✓ Start a COVID-19 vaccine series within 90 days of arrival to the United States. You will also need to complete the recommended primary vaccine series so you are considered fully vaccinated.

Tuberculosis (TB) Screening

Required for ages two years and older

Parolees over the age of two years old must complete Tuberculosis Screening and the required attestation within 90 days after U.S. arrival. You will need to attest to one of the below:

- ✓ **Your TB test result is negative.** This means you have had TB screening starting with an IGRA (interferon-gamma release assay) blood test, and the test result is negative. You will need to agree to keep a copy of your IGRA test results.
- ✓ **Your test result is indeterminate.** This means you have had screening starting with an IGRA (interferon-gamma release assay) blood test and your results are indeterminate (meaning uncertain). You will need to have more testing, so you must agree to follow up with a state or local public health office or doctor’s office. You will also need to agree to keep a copy of your IGRA test results.
- ✓ **Your test result is positive.** This means you have had screening starting with an IGRA (interferon-gamma release assay) blood test and this screening was positive for tuberculosis. Because you might have active tuberculosis you must agree to receive a chest x-ray. If your chest x-ray is abnormal or if there are other signs or symptoms of active tuberculosis disease, you must agree to follow the isolation and treatment measures as decided by the state or local public health office or your doctor’s office. You will also need to keep a copy of your IGRA test results, as well as documentation that you followed up for additional testing and treatment.

Where can I make my attestation?

Within 90-days of arrival in the U.S., parolees must complete their attestation in their USCIS online account.
