## 1. Mission

Our mission is to **help Ukrainians seeking refuge find safety and stability in the United States**. We do this by providing timely guidance, education, and resources on U.S. immigration law and related topics.

# 2. Stakeholders

We serve Ukrainians in the United States and abroad, as well as their families, support networks, and advocates. Our stakeholders include:

- Displaced Ukrainians, their relatives, friends, individual sponsors, and organizational sponsors
- Immigration attorneys, social services staff, resettlement agencies, and refugee aid groups

# 3. Core Programs

- Publishing materials on immigration laws and procedures in various languages
- Educating Ukrainians on immigration, benefits, rights, safety, and regulatory requirements
- Holding webinars and clinics on immigration applications, programs, and other topics
- Informing stakeholders of relevant regulatory updates affecting Ukrainian immigration
- Providing general guidance and clarifications on immigration laws and procedures
- Providing virtual support with key immigration forms and processes

## 4. Other Programs

- Partnering with organizations to connect new arrivals with material resources and information
- Collaborating with communities and nonprofits to create and disseminate important content
- Consulting organizations on immigration pathways, procedures, benefits, and compliance
- Providing cultural validation and translation review to ensure accuracy and cultural resonance
- Promoting sponsorship, community support, and best practices for assisting Ukrainians
- Raising awareness about procedural and safety issues while advocating for more stable policies
